MLA outlined that his Ministerial portfolios now included Municipal and Community Affairs. His portfolios of Energy and Natural Resources, Lands and Municipal and Community Affairs and Lands work well together.

Meeting with Minister of Housing scheduled for May was cancelled due to illness of President of the NWT Housing Corporation.

MLA will meet with community on July 7th with the Minister of Infrastructure.

Councilor Dewin Kotchea inquired about a permit to harvest logs for a cabin. MLA responded that permit was required, and cost was minimal.

Mayor Cathy raised concern about Timberline Wood Services damaging well over ten trees. Issue raised with Fort Liard RWED Officer but no response. Unknown if this is being done in more areas. MLA asked for a formal request for investigation.

Councilor Julia Capot Blanc inquired why passport photos cannot be obtained in Fort Liard, MLA responded that GNWT cannot process due to technical requirements and that this would require a contractor with equipment. GNWT only responsible for NWT ID Cards and arrangements can be made for these to be processed. First Nations are responsible for Treaty Cards and arrangements would need to be made with Acho Dene Know First Nation.

Discussion concerning COVID procedures at the BC Boarder. MLA said by could respond specifically but concerns need to be raised with the Department of Health. There are challenges to opening the BC Boarder while keeping the community safe. Question – how do Fort Liard hunters' access there traplines in BC during Fall Hunt? Officials from the GNWT will meet with the community to discuss opening the BC Boarder.

The MLA and two Superintendents left the meeting.

## **DEVELOPMENT PERMIT**

Council reviewed a development permit from the NWT Housing Corporation to construct a 2500 square foot singles four plex on Lot 67 LTO 1910. This lot is zoned residential, and council may approve conditional construction of multi-unit housing. The lot is of adequate for a building of this size. Access points for services meets standards. There was no objection to the approval of this development permit.
