#### 6) <u>DELEGATION</u>

- A) ADKFN Chief and Council were scheduled to discuss the wellness program transition but didn't attend. Jacqueline Spies attended. The Mayor wanted to hear from Chief Hope not ADKFN staff.
- B) RCMP Cpl. Nick Brodeur gave a verbal update in statistics for Fort Liard. Spoke about getting the Justice Committee up and running is important and RCMP is working with ADKFN and Julie Capot-Blanc and Eve Hope. Council needs a written report so everyone can be brought up-to-date on the status of the committee. Jacqueline Spies said ADKFN submitted the grant application and that by Sept 20, 2017 the committee could be up and running. The detachment will be keeping the boat as reports show usage over the past few weeks and the Deputy Regional Commander was in the community and said the boat stays.
- C) George Jooris applied for a development permit in 2014 and was denied. But a meeting of council was given verbal go ahead but nothing in writing. A letter from Hamlet Council was sent out dated June 9, 2014 indicating that his application was denied and listed numerous reasons as to why. After much heated discussion, Mr. Jooris agreed to meet with SAO Mike Rudkin on Aug 14, 2017 to further discuss what is required in order to obtain a development permit.

#### 8) **BUSINESS**

8A) ADKFN request for free use of the recreation centre and kitchen for the handgame tournament Aug 19-21, 2017. SAO had indicated that in prior years they had left the facility is such disarray that he suggested that they not be allowed to use the facility. Further that the hamlet would need to have a staff member there for the time required and that there is no budget for this. The kitchen has not been used for free and that should be paid for as other groups have. After much heated debate, a vote was taken: 2 in favor and 2 against. So, the Mayor made the deciding vote to allow the use of the facility. There are conditions that must be met: ADKFN is responsible for keeping the facility clean at all times, MUST have someone monitor the washrooms on an ongoing basis thru out the tournament, ADKFN is responsible for any/all damages. The SAO said the kitchen has not been used for free and that ADKEN should pay for the use as others have in the past. Also, ADKFN needs to provide proof of insurance and a certificate of insurance be issued showing the Hamlet of Fort Liard on and also stating the function and dates of same.

ADKFN letter regarding the Wellness Program - the Chief of ADKFN wrote a letter to the GNWT regarding taking back the wellness program from the Hamlet of Fort Liard in Sept 2017. The SAO contacted Chris Stipdonk, Regional Wellness Coordinator regarding this. As well as Sabrina Broadhead. The hamlet has the CA agreement until March 31, 2018. That will remain enforce and the hamlet is encouraged to continue with the community consultation and update the wellness plan. By doing so can apply for the next round of funding. The hamlet should encourage ADKFN to participate in this process as they maybe the group running the wellness program come April 2018. Sabrina Broadhead suggested having a meeting between ADKFN and Mayor and Council to discuss the wellness program and facilitate of smooth transition. SAO is to write a letter to ADKFN requesting this and setup a date and time for the meeting. Sabrina Broadhead and Chris Stipdonk will attend.
