GNWT – Small Communities Employment Support Program. This program was administered by ECE previously and is now been downloaded to the municipality to run. This program support wages only to enable local businesses/organizations to assist is providing employment and reduce dependency on other GNWT programs. SAO provided 2 applications submitted. 1 was denied as the Hamlet can't be the only group being awarded funds. SAO said Hamlet must put out a call for proposals and review what other groups need. And bring back an updated list of submissions.

8D) ADKFN request for free use of the hall and kitchen for the hand game tournament Aug 17-19, 2018. Council discussed this in length and decided to provide the hall at no charge, but the kitchen is to be billed out are regular rental rates. A certificate of insurance in the amount not less than \$2,000,000 is required prior to the start of the tournament. SA pointed put that hamlet requires a staff person to open/close clean up. The cost of this will be more than the rental fee collected.

Solid Waste/Hazardous Waste cleanup – SAO explained that the area at the solid waste site is nearing capacity and needs to have the hazardous waste, bulk materials etc. removed from the site ASAP. If this isn't done, then the Hamlet could face fines for not adhering to the legal requirements to do so.

The cost of this would be up to approx. \$63,390 to do all the work needed. Council approved the request.
